Water Resources Department - Establishment - Redesignaion of the post of Chief Engineer, Kuttanad Package as Chief Engineer(Inland Navigation & Kuttanad Package) and Transfer of full jurisdiction of development of Inland Waterways from Chief Engineer(I&A) to Chief Engineer, Kuttanad Package - Sanctioned - Orders issued.

**ORDER**

As per the existing delegation, inland navigation is under the jurisdiction of Chief Engineer(Irrigation & Administration)in addition to the charge of Irrigation and Administration, Minor Irrigation and Inter State Water. Government of Kerala proposes to develop the inland navigation network in the State to national waterway standards. This necessitates concentrated efforts to ensure timely completion of the project and hence requires a full fledged Chief Engineer dedicated to Inland Navigation development. Accordingly, Government are pleased to transfer jurisdiction over Inland Navigation development from the Chief Engineer(I&A) to the Chief Engineer(Kuttanad Package).

2) In the above circumstances, the post of Chief Engineer(Kuttanad Package) is redesignated as Chief Engineer (Inland Navigation & Kuttanad Package) and the full jurisdiction of development of inland waterways is transferred from the Chief Engineer(I&A) to the Chief Engineer(Inland Navigation & Kuttanad Package).

3) The Chief Engineer (Inland Navigation & Kuttanad Package) will exercise jurisdiction overall the existing offices related to Inland Navigation in the State.
