ORDER

As per the common judgment read as 1st paper above, the Hon'ble Administrative Tribunal directed the 1st Respondent State of Kerala to consider and pass appropriate orders on Annexure A20 appeal preferred under Rule 28(b)(i)(8)(a) in accordance with the provision under Rule 28(b)(i)Part II KS&SSR. It was also directed that the 1st Respondent shall pass appropriate orders within a period of one month from the date of receipt of a copy of the order after affording an opportunity of personal hearing to the applicant. Accordingly the petitioner was heard on 26/12/2018.

2) In compliance of the above Order, an Adhoc Departmental Promotion Committee was conducted on 29/01/2019. As per the decision of the Adhoc Departmental Promotion Committee, Select List of Assistant Executive Engineer(Civil) under Degree Quota for the year 2013 for promotion to the post of Executive Engineers(Civil) and Select List of Executive Engineers under Degree Quota for the year 2018 for promotion as Superintending Engineers were modified as per Notifications read as 5th and 4th papers respectively including the name of Sri.Najeeb M.

3) As per letter read as 6th paper above the Chief Engineer(I&A) has furnished a proposal for the promotion and posting of Sri.Najeeb M., Executive Engineer as Superintending Engineer in the Scale of Pay of Rs.85000-117600 in the post of Deputy Chief Engineer(Vigilance) in the Office of the Chief Engineer(I&A), Thiruvananthapuram in the post sanctioned vide G.O(Rt)No.797/18/WRD dated 5/11/2018.

4) Government have examined the matter in detail. Sri.Najeeb M, Executive Engineer, KIP(RB) Division No.2, Kottarakkara is promoted and posted as Superintending Engineer in the Scale of Pay of Rs.85000-117600 in the post of Deputy Chief Engineer(Vigilance) in the Office of the Chief Engineer(I&A), Thiruvananthapuram.
