**Order No. B2-20001/2018 Dated 06/10/2018**

As per orders read as second paper above, 26 (twenty six) senior-most Head clerks in this department were promoted as Junior Superintendents. Sri. Anil John, Head Clerk, who is ranked as serial No. '182' in the final seniority list of Head Clerks published vide proceedings 1<sup>st</sup> read above, was not considered then for promotion as Junior Superintendent, for want of declaration of his probation in the cadre of Head Clerk.

Now, orders have been issued, vide proceedings read as third above, declaring his probation in the cadre of Head Clerk with effect from the F.N of 25.09.2016.

Accordingly, orders are hereby issued promoting Sri. Anil John, Head Clerk to the cadre of Junior Superintendent provisionally as per KS & SSR in the scale of pay of Rs. 30700-65400 and posting him at the O/o the Chief Engineer, IDR B, Thiruvananthapuram in the existing vacancy. He will be on probation for a period of one year on duty, from the date of joining duty as Junior Superintendent within a continuous period of two years in service. The promotion ordered above will have retrospective effect from 12.06.2018 as his immediate junior Sri. C.N. Harikumar, Head Clerk (ranked '183' in the final seniority list first read above) was promoted to the cadre of Junior Superintendent vide the proceedings second read above.

The promotion ordered above is purely provisional and shall be subject to review based on the decision to be taken by the department on the findings of Anomaly Cell, which was constituted to look into the defects, if any, in the assignment of seniority in the clerical cadre in the department.

Sri. Anil John, Head Clerk shall join duty as Junior Superintendent in the new station forthwith. The controlling officers concerned shall download copies of the order from the official website of the department and issue necessary relieving / posting orders to the incumbent under intimation to this office.
