In the circumstances reported by the Chief Engineer (I&A), Thiruvananthapuram in the letter read as 3rd paper above, the following officers in the cadre of Executive Engineer in Irrigation Department are sanctioned Ratio Based Higher Grade in the scale of pay of Rs.40640-57440/- with effect from the dates noted against their names subject to the observance of all conditions stipulated in Government Order read as 1st paper above and subject to the condition that the total number of Executive Engineers(Higher Grade) shall not exceed 25% of the total sanctioned cadre strength of Executive Engineers in Irrigation Department at any point of time.

Those who are nominated from 01/04/2016 will be eligible for promotion to Higher Grade in the Scale of Pay of Rs.77,400-1,15,200/-.
