ORDER

As per letter referred 1st above, Chief Engineer Irrigation & Administration has given direction to all Chief Engineers under Irrigation Department to issue NOC/Clearance for all works submitted by Kerala Water Authority which involves laying of pipe line along or across bund/canal road or any other irrigation work without availing supervision charges/security deposit until further orders. The said direction is issued considering the fact that JJM supply of Drinking water for which the works taken up by KWA needs to be completed on a time bound manner as fixed by Government of India. However, NOC shall be issued with a provision that "any such restoration charges that will occur/ has been occurred shall be paid by KWA at the rate fixed by the Government (including retrospective charges as fixed by Government) the same of which shall be included in the Guildelines formulated by Irrigation Department".

2. As per letter referred as 2nd paper above, Chief Engineer, Irrigation & Administration has requested to ratify the action.
