ORDER

As per G.O read as 1st paper above, Government have approved the Standard Operating Procedure(SOP) for desiltation of reservoirs in Kerala and accorded sanction for carrying out desiltation of Mangalam and Chuliar Dams as pilot projects, one by adopting the work contract method and the other by turnkey method. As per Standard Operating Procedure a Technical Committee and Empowered Committee are to be constituted.

The role of Technical Committee is as follows:

• To vet and accept the estimated quantity of components in the deposited sediments as well as estimated cost of each component material/ estimated cost for extraction, processing, separation and packing etc. of each component material.

The role of Empowered Committee is as follows:

- To scrutinize the DPR in consultation with the Chief Technical Examiner.
- To decide and approve the bidding method (Method 1- Turn key Method or Method 2- Work contract) to be adopted for a particular project in consultation with Chief Technical Examiner.
- Fixation of installment amount to be paid to the Government for Method 1- Turn key Method.
- Approval of variation in the estimated quantity of total sediments and realized total quantity in consultation with the Chief Technical Examiner.
- Monitoring the progress of work and redressal of disputes, if any, arising during execution of work
