## Minutes of the Technical Committee meeting held on 07/05/2020 in the chamber of Chief Engineer, Irrigation & Administration, regarding the discussion of bids received for Expression of Interest called for the preparation of Detailed Project Report for desiltation of 10 reservoirs under Irrigation Department.

The meeting commenced at 11:00am.

The chairman Dr.Udaya Kumar A (Chief Engineer, Irrigation & Administration) presided over the meeting. The Chairman informed the members that after the vide publicity, Expression of Interest (EoI) for preparing the Detailed Project Report (DPR) of 10 Reservoirs under Irrigation Department was invited. No bids were received even after extending the time of submission of EoI first time. Two bids were received for the EOI after the 2<sup>nd</sup> extension of the same. The bids were submitted by BUILD MET PRIVATE LIMITED, (An Ayoki Group Company), KKR Pearl, Survey no:58/1, Nagashetty Halli, Kasaba Hobli. Hebbal-Tumkur Outer Ring Road, Bangalore- 560094 and MANTOVANI DI DHARTHI PRIVATE LIMITED, Flat no.103, Sravya Vatika Building, B.S. Maktha, Begumpet, Hyderabad, Telangana -500016. He also informed that the financial bids should be opened only after the approval from Empowered Committee.

Detailed discussion had been conducted on the 8 points of the criteria and unanimously decided the following:

- 1. As per the Expression of Interest (EoI), "The firm should have an average annual turnover of Rs 100 crores in the last five consecutive financial years". But the two bidders, BUILD MET PRIVATE LIMITED and MANTOVANI DI DHARTHI PRIVATE LIMITED have not fulfilled the criteria. The BUILD MET PRIVATE LIMITED has an average annual turnover of Rs 61.75 crores for the last four years and MANTOVANI DI DHARTHI PRIVATE LIMITED has an average annual turnover of Rs 239.55 crore for one year. Hence the score is taken as zero (0).
- 2. All other items are evaluated in accordance with the criteria stipulated in the Eol.
- 3. In the criteria for manpower received (point no: 8), both the companies have assured enough technical professionals
- 4. The total score of BUILD MET PRIVATE LIMITED, is **79.4** and that of MANTOVANI DI DHARTHI PRIVATE LIMITED is **22** excluding the criteria for annual turnover (criteria no:3)
- 5. Regarding the score on criteria no. 3, Government may take appropriate decision.

Based on the above points, the Technical Committee decided to submit the facts to the Government that only one firm (BUILD MET PRIVATE) has qualified, the qualifying criteria of total score above 60.

The meeting concluded at 12:00pm.
