Minutes of the Technical Committee meeting held on 10.08.2020 at 2.30PM through Video conference.

The Technical Committee meeting for the Desiltation of Mangalam Reservoir was convened through google meet, due to the prevailing lockdown condition in the country, on account of current pandemic situation of COVID-19.

The meeting chaired by Sri.Biju.D. Chief Engineer, Irrigation and Administration commenced at 2.30PM.

Opening the discussion, the Chief Engineer, Projects 1 informed the committee that the meeting has been convened to discuss the reevaluated technical bid documents for desiltation of Mangalam Reservoir as per the decision taken in the technical committee meeting held on 04.08.2020. SE, SPC, Palakkad explained that according to the decision taken in the technical committee meeting held on 04.08.2020, bidders were given two days time for submitting additional documents if any from 10AM on 05-08-2020 to 5PM on 06-08-2020. Additional documents were submitted by all the four bidders. Bids were reevaluated and accordingly marks were corrected. The committee compared the marks obtained before and after reevaluation. The committee observed that even though Dharti Infrastructure Ltd. had not submitted valid license earlier, they submitted Karnataka PWD Civil/Electrical contractor's license valid up to 12.02.2021 on 06.08.2020 by email. Chief Engineer, Projects 1 pointed out that Dharti has not submitted the credit facility certificate but reported that due to COVID 19. banks are unable to issue letter and assured that they can raise the funds through their internal resources. Committee decided that as the criteria of credit facility is not considered for assigning marks, there is no need of disqualifying the firm. After scrutiny of the submitted details, the committee decided to qualify the following firms who obtained minimum score of 60 and met all other requirements as per bid document.

- 1. Dharti Dredging and Infrastructure Limited with 80 marks
- 2. Suryodaya Infra Projects(1) Pvt. Ltd. with 74 marks
- 3. Marymatha Infrastructure Pvt. Ltd. with 65 marks

The committee decided to reject the bid submitted by Sri. Shihas P.I as he has not submitted all the documents required for technical qualification and also not scored the minimum score.

After detailed discussion the following decisions were taken:

Decisions

- 1. To qualify the following firms:
 - I. Dharti dredging and Infrastructure Limited
 - 2. Suryodaya Infra Projects (1)Pvt Ltd.
 - 3. Marymatha Infrastructure Pvt Ltd
- 2. To reject the bid submitted by Sri. Shihas. P.I.
- 3. SE, SPC, Palakkad is directed to upload result of evaluation on e-procurement by 11.00AM on 11/08/2020 following which any bidder may submit complaint which shall be considered for resolution before opening of financial bid.
- 4. To open the financial bid by 3.00PM on 13/08/2020.
