

MINUTES OF THE TECHNICAL COMMITTEE MEETING FOR DESILTING OF
MANGALAM RESERVOIR AT PALAKKAD DISTRICT KERALA ON 24.04.2020
AT 2.00 PM THROUGH VIDEO CONFERENCE

The Technical committee meeting for the desilting of Mangalam reservoir was convened through online video conference due to the prevailing lock down condition in the country on account of current pandemic situation of COVID-19 so as to assess the revaluation of Technical bid as decided in the TC held on 23-4-20.

Opening the discussion, Chief Engineer, Projects-1 invited the Superintending Engineer, Siruvani Project Circle to present the status after the reevaluation of bid. The Superintending Engineer informed that as directed by TC the technical bid was reevaluated by giving score in proportionate manner for the items Sl. No.3 - Annual Turnover and also for Sl. No.5 Specific Dredging & Contract Management Experience of last five years, accordingly the score of these item was modified as 6 & 3 respectively.

The Superintending Engineer reported that under Sl.No.6 Qualification of person in key position, the bidder has submitted the details of persons through email and had informed that due to prevailing lock down conditions the offices are closed at present and shall submit the same as soon as the office function resumes.

Technical Committee discussed the revaluation and opined that the score given for Sl. No.3 & 5 can be accepted. In case of Sl.No.6 even though the bidder has not attached the copies of experience certificate, considering the documents forwarded through their e-mail, on reassessment the bidder is eligible for 15 points.

On revaluation of the bid as directed by Empowered committee, the overall score obtained by the bidder is 61.5 out of 100. The score for General and specific dredging experience Sl. No. 4 & 5 of score sheet taken together, has increased from 9.5 to 10.5 out of 40 (minimum of 25 score out of 40 is required)

Taking into account the facts that the desilting of Mangalam Dam is taken up as the pilot project of the state and considered as a benchmark for carrying out the desilting of other reservoirs, also in spite of repeated extension of date of bid submission no response except this single bid has been received .


Technical committee unanimously took the following decision :

- The overall score is **61.5 out of 100**, even though the bidder has not scored a minimum of 25 marks out of 40 for- General and specific dredging experience Sl. No. 4 &5 together , financial bid may be opened on receiving consent from government .
- The Superintending Engineer Siruvani Project Circle may open the financial bid and submit the financial bid evaluation report immediately.

The Technical Committee decided to submit the same to Government for further necessary action
