The Superintending Engineer, Siruvani Project Circle, Palakkad, Kerala, India for and on behalf of Governor of Kerala now invites International Competitive Bidding in electronic tendering system for selecting a Contractor for awarding the DESILTATION OF VENKALAKAYAM ERI AT PALAKKAD DISTRICT, KERALA, INDIA as detailed in the table.

2. The Set of bidding documents comprises of Doc1 containing (i) PART 1 Bidding Procedures (ii) PART 2 Work Requirements (iii) PART 3 Conditions of Contract and Contract forms.

3. The bid document is available online and bids are to be submitted online through e-tendering portal [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). Bids submitted manually alone will not be accepted. The bidders would be required to register in the web site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities. “Aspiring bidders who have not obtained the user ID and password for participating in e-tendering may obtain the same by registering in the web site: [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). Digital Signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from the authorized Certifying Authorities can use the same in this tender.

4. Bidding will be conducted through the International Competitive Bidding procedures and is open to all bidders as defined in the Guidelines. Only eligible bidders with following key qualifications shall participate in this bidding.

5. The bidders shall furnish, as part of the bid, bid submission fee and bid security (EMD) for the amount as specified through ONLINE NEFT TRANSACTION. Any bid not accompanied by an acceptable bid security hereof shall be rejected by the Employer as non-responsive. The Bid security of unsuccessful bidders will be returned as promptly as possible upon successful bidders signing of contract. The Bid Security of successful bidder will be discharged when the bidder has furnished the required Performance Guarantee and signed the Agreement.

The Bid Security may be forfeited:

i.If the bidder withdraws the bid after bid opening during the period of the bid validity

ii.In the case of a successful bidder, if the bidder fails within the specified time limit to sign the agreement or furnish the required performance security.

6. No special preference will be accorded to any bidder, either for price or for other terms and conditions, when competing with foreign bidders, state-owned enterprises, small-scale enterprises or enterprises from any given state.

7. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The procedure followed for opening of bid is specified in ITB 24.1 (Bid opening). The highest bidder will be finalized after evaluating the bids vide ITB 36.1.

8. The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.

9. Other details can be had from the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond his control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information/corrigendum related to the bid.
