The following 1st Grade Draftsman/Overseer under Diploma Quota and Certificate Quota included in the select list prepared by the Departmental Promotion Committee (Lower Technical) in the meeting held on 15-02-2024 and approved by Government vide notification read as 2nd paper above are “appointed by transfer” as Assistant Engineers (Civil) in the scale of pay Rs 55200-Rs 115300 (Revised) as per Rule 9 (a) (i) of General Rules in KS&SSRs and they are posted in the open places noted against their name. The promotion will be subject to the final outcome of OA(EKM) 148/2024.

The incumbents so appointed are placed under probation for a period of two years on duty within a continuous service of three years as per Government order read above. During the period of probation they will have to pass the obligatory departmental tests conducted by KPSC viz. Account Test (Lower) (4 Papers), PWD Test (2 papers) and PWD Manual Test for successful completion of the period of probation in the cadre of Assistant Engineer (Civil). The controlling officers are directed to verify the records of qualification of the officers so appointed as Assistant Engineers (Civil).

All other prevailing conditions regarding the “appointments by transfer” are applicable to these persons also.
