As per G.O read (2), Government has implemented National Pension System (NPS) in the state for all appointments made on or after 01/04/2013. NPS would be mandatory for all appointments.

The appointment is purely provisional subject to Rule 3 (c) of General Rules of KS & SSR, 1958. The incumbents shall report for duty before the officer where he/she is posted within 15 days from the receipt of the posting order with necessary certificate in original to prove date of birth, qualifications, Non-creamy layer certificate, one time verification certificate and also a certificate of health obtained from a Govt. Medical Officer not below the rank of Assistant Surgeon, wherein a photograph to be affixed and attested. The thumb impression of the incumbent is also to be put on the certificate. The photograph and the signature of the candidates should be verified and the fact should be recorded on the scanned copy of the Identification Certificate itself.

The Certificate produced are also should be verified and the fact should be recorded on the Identification Certificate itself. If there is any discrepancy, the candidates should not be allowed to join duty and the fact should be reported to KPSC District Office, Kollam with intimation to this office. After the candidates are allowed to join duty, the verified scanned copy of Identification Certificate should be kept pasted in his/her Service Book. The candidates appointment is subject to regularization subsequently on verification of character and antecedents and also of obtaining a verification certificate from the KPSC. His/Her service is liable to be terminated without notice if found subsequently unsuitable for appointment in Government service. Within one week after the candidates joins duty, a Service Book shall be opened and a photocopy of relevant page containing details such as name, address, personal identification mark and thumb impression shall be forwarded to the Chief Engineer's Office without fail. The incumbent must produce one of the ID proof (Election ID / Passport / Driving License / Aadhaar Card) at the time of joining duty. The Annexure-I and the statement of movable and immovable

properties should be filled in and submitted at the time of joining duty. The Forms should be downloaded from the Irrigation Website.

Application for correction of date of birth if any needed, shall be made within 5 years from the date of entry in service as provided in G.O (P) No.45/91/P & ARD dated: 30-12-1991.

In the event of discharge from service for want of vacancy the candidates may either register his/her name in the office of the KPSC from where advised in order to get themselves reappointed on further advice by the KPSC or they may wait for their turns for reappointment to the post in the department.

The appointment is also governed by the provisions contained in G.O. (P) No. 441/2012/Fin dated: 08/08/2012. The incumbents will be on probation for a period of 1 year on duty within a continuous period of 3 years service.
